39 locations selected

- This study showed consistency with another study in this region that highlighted the significant methods of the government disseminated social media during the pandemic emergency.
- However, this could be differed from another country that reported rural communities' close links with both local governance and NGOs.




CONCLUSION

The findings offer an opportunity for stakeholders in identifying the main platforms for effective risk communication during health emergencies and strategising response plans.





